Are you a Disabled Person who hasn't been provided with a Personal Evacuation Emergency Plan (PEEP)?

A PEEP is a plan for a person who may need assistance, for instance, a person with impaired mobility, to evacuate a building or reach a place of safety in the event of an emergency. We are encouraging any Disabled person who has been left without one to submit a formal complaint to their housing organisation, so you are protected and there is more attention drawn to the necessity of providing PEEPs.
